**Preamble :-**

The Government of India passed the RTE Act as per reference – (1), that Right of Children to Free and compulsory Education to all children age group of 6 to 14 years. To implement the RTE Act State Government issued as per reference–(2) formed notifications of Gujarat RTE Rules -2012 date 18-2-2012.

2. As per Government of India reference - (1) RTE Act-2009 section (34) as per State Government reference – (2) rules are formed to provide guidance for implementation of RTE Act provision and for advise to State Government to these rules; Rule-(33) State Advisory Council has been formed. The State Government was under active consideration for formation of State Advisory Council. As per mature decision of Gujarat RTE Rules-2009 Rules-33 State has decided to formed State Advisory Council by resolution.

**Resolution:-**

As per implementation of RTE Act 2009 and the State Rules (Reference -2) State Government provided an advised to form state level, State Advisory Council as per following:

2. A part from the above mention members additional seven non-governmental members will be recruited.

3. As per Gujarat RTE Rule -2012 Rules-33(6), the procedure of transaction for Business of the Council shall be as under:

- (a) The Council shall meet regularly at such times as the Chairperson thinks but three shall not be gap of more than three months between two meetings.
- (b) If for any reason the Chairperson is unable to attend the meeting of the Council, he may nominate a member of the Council to preside over such meeting.
- (c) Quorum of the meeting of the Council shall be considered complete if at least 50% of its members are present.

4. Recruitment of the council members are followed by the terms and conditions of the council, Gujarat RTE Rules-2012 Rule-33(7) and Right of Children to Free and Compulsory Education Act-2009.

5. The Council of State Governments will provided time to time orders and instructions as per State Government RTE Act-2012 Rule-34 for advice regarding Primary Education.

6. Traveling allowance admissible to the Non-Governmental members of the Council for office work is in accordance with the Finance Department date:18-9-2008 resolution No.MSB/102008/220/CH.

7. Above orders are issued as per the approval on the note of Treasury Department file date 11-1-2013 and Government approval on note date 16-3-2013.
